## ELIGIBILITY:

- **ARTISTS MAY ENTER A MAXIMUM OF 4 WORKS**
- All Southern California artists. Works must be original and have been completed since January 2005.
- City of Los Angeles Department of Cultural Affairs employees are ineligible.

## SUBMISSION:

Submit a CD containing 4 artworks numbered 1 through 4.  
Artworks must be in JPEG format (NO Tiffs, PDF or PowerPoint)  
(Image files must not exceed [500] KB each, and should have a maximum image size of [2400] pixels x [3000] pixels each, 8 X 10 inches and 300 DPI).  
Complete ENTRY FORM - number 1 - 4 to correspond to your CD

## FEE:

- \$10.00 per work.  
Check, cashiers checks, money orders payable to LAMAG Associates. Cash entries accepted ONLY if hand delivered to the Municipal Art Gallery. **Entry Fee Non-Refundable**

## CATEGORIES:

- Painting (encaustic, oil, water-based media, canvas or panel)
- Sculpture (three-dimensional works: pedestal, floor or wall hung works)
- Works on Paper (water or oil-based media, collage, photography, digital imagery, printmaking)
- Mixed Media/Assemblage (work formed by combining different materials, also includes fiber and textile works)
- Video (DVD)
- Installation
- Performance Art

## DISPLAY REQUIREMENTS:

### Two - dimensional work:

- All works MUST be ready to hang with wire and eye hooks.
- Works on paper must be covered by glass or Plexiglas.
- Maximum size: 132 inches (height) - Minimum size: no less than 10 X 10 inches.
- Plexiglas or Glass MAY NOT be used with metal/clip frames if any one side exceeds 25 inches.

## Three- dimensional work:

- May use up to 3 images to represent 1 work (front, back, side)
- Maximum size: 118 X 64 inches - Minimum size: no smaller than 10 X 10 inches.
- Weight maximum 150 lbs.
- Provide pedestals as necessary.

## Installation works:

- One page or less narrative along with 3 images addressing the contents and components of the proposed work.
- Installation artists must install their own work and provide all the necessary equipment.
- Video
- DVD must be cued for jurors. The DVD must be no longer than 3 minutes.

## Performance Art:

- Send one DVD to show previous work presented within the last two years to assess performer's ability. One page or less narrative describes the contents of the proposed work.

## INADMISSIBLE WORK:

Unfinished, incomplete or wet works, and any work considered unsafe will not be accepted, No live animals, no hazardous materials and no perishables.

## SALES

Inquiries for purchase will be directed to the artist or representative.  
The Los Angeles Municipal Art Gallery does not handle sales of artwork.

## CHECK LIST:

1. Fee: \$10.00 per work.  
Check, Cashiers check or money order should be made payable to LAMAG Associates (LAMAGA)  
Cash will be accepted ONLY if hand delivered to gallery staff.
2. OPTIONAL: Self-Addressed Stamped Envelope (4 x 9 \_ inch) for return of CD otherwise CD will be discarded
3. Completed ENTRY FORM signed by artist. Incomplete entries will not be accepted.
4. Entries (4 Max)
5. DVDs cued for jurors
6. Performance DVD's cued for juror and a written statement.
7. Please do not include Resumes

- Entries must be post marked on or before May 30, 2008
- Notification of juried results mailed on third week of June 23rd
- Exhibition dates: July 31 - September 7, 2008
- Opening Reception: Sunday, August 3, 2- 5pm.

## CATEGORIES:

- Painting (encaustic, oil, water-based media on canvas or panel)
- Sculpture (three-dimensional works: pedestal, floor or wall hung works)
- Works on Paper (water or oil-based media, collage, photography, digital imagery, printmaking)
- Mixed Media/Assemblage (work formed primarily by combining of different materials, also includes fiber and textile works)

## DISPLAY REQUIREMENTS:

### Two - dimensional work:

- All works MUST be ready to hang with wire and eye hooks.
- Works on paper must be covered by glass or Plexiglas.
- Plexiglas or Glass MAY NOT be used with metal/clip frames if any one side exceeds 25 inches.

### Three- dimensional work:

- Weight maximum 100 lbs.
- Provide pedestals as necessary.

## DELIVERY:

- Artwork must be hand delivered to the Junior Art Center Gallery, on July 16 from 9am - 5pm. The work will be reviewed by our juror.
- Accepted art will remain on exhibit from July 31- September 7, 2008.
- Work not accepted will be picked up on July 18 from 10am - 5pm.
